Sub. Selection for promotion to the post of Chief Controller (CTNL) (50% LDCE Quota), Pay Matrix Level-7 (PB - II Rs. 9300-34800+ GP Rs.4600) Optg (Tfc) Deptt - ADI Division.

It is proposed to hold selection for promotion to the post of Chief Controller (CTNL) (50% LDCE Quota), Pay Matrix Level-7/ (PB -II Rs. 9300-34800+ GP Rs.4600) against 50% Limited Departmental Competitive Examination of Operating / Traffic Department- ADI Division.

**(1) Eligibility Criteria: -**

- (i) The employees may apply who are working as Station Master, (Pay Level-6), Train Mangers (Pay Level-5 & Pay Level-6) & Section Controllers (Pay Level-6) having completed a minimum of 2 years' service in lower grade, subject to passing of a prescribed refresher course and Psychometric Test as per RDSO specifications for those who have already not passed such a test in lower grades Traffic (Transportation) department.
- (ii) Those selected as Chief Controller (CTNL) (50% LDCE Quota), Pay Matrix Level-7 (PB -II 9300- 34800+ GP Rs. 4600) will be required to complete a course of training at Udaipur (ZRTI) as well as to undergo practical training. The employee who will complete the prescribed training successfully will be eligible for promotion in accordance with the order of merit as determined by the selection board. The applicant should note that after the selection and training if refuse to work as Chief Controller (CTNL) (50% LDCE Quota), Pay Matrix Level-7 (PB -II 9300-34800+ GP Rs. 4600) the entire period of training will be treated as leave due and excess amount drawn will be recovered.

**(2) Mode of examination:-**

- (i) As per RBE 196/2018 the question paper will be 100% objective type will be CBT/OMR based examination and there will be no supplementary exam.
- (ii) The selection will consisting written examination as well as scrutiny of service records & there will be negative marking of 1/3<sup>rd</sup> marks on each wrong question.
- (iii) Penal will be formed in order of merit of the employees who will qualify in the CBT/written Test.
- (iv) In terms of RBE 17/2014 being safety category there will be no additional relaxation given to SC/ST employees of 10% marks in examination and as per RBE 57/95 there is no any provision of Best amongst failure to SC/ST Employees.
- (v) Being selection post there is no provision for Supplementary examination for employees who will remain absent in exam.
- (vi) **Pre-Selection Training.** : - In terms of instructions contained in Railway Board's Lr No. 88-E(SCT)/I/42/2 Dated 11.04.1991, the pre-selection training for eligible SC-ST Volunteers will be conducted covering the syllabus of said examination, date of Pre-Selection Training will be issued separately.

- (3) The willing and eligible employee may submit their application as per proforma enclosed along with attested copy of graduation certificate, age proof certificate and also caste certificate in of SC/ST candidates.
- (4) The employee may submit their application to Incharge concerned on or before 13.12.2025 (Saturday) as per enclosed performa and after scrutinizing all the applications the in-charge should forward the eligible employee's application in a bunch to this office address to Ch.OS of Estt. Traffic Section- DRM (E) ADI's office on or before 15.12.2025 (Monday) without fail. No application will be entertained submitted after 13.12.2025

- (7) Date of written Test/CBT will be notified later on separately. The willing & eligible employees should be in readiness for appearing in the written test/CBT. They can be called for written test in short notice.
- (8) Syllabus for the notification will be notified separately.
- (9) Employee's medical standard is required to be Aye-Two (A-2).
- (10) The employee who will be empaneled, are liable to be posted at any station of ADI division as per requirement of Administration.
- (11) Copy of notification may be also fixed on notice board & for giving wide publicity.
- (12) All the employees are bound with the all Rules and circulars issued by Railway Board regarding the selection at any stage of the selection.
