All Concerned - Operating (Traffic) Dept. - Bhusawal Division.

Sub: Selection for promotion to the post of Station Master in Pay Level-6 (GP 4200) against 25% General Selection Quota in Operating Department of Bhusawal Division.

1. It is proposed to fill up 29 vacancies for the post of Station Master in Pay Level- 6 against 25% General Selection Quota in Operating Department of Bhusawal Division. Bifurcation of vacancies is as under:

2. i. **Eligibility and service conditions:**

(a) Shunting Jamadars, Shunting Masters, Cabinmen Grade-1, Switchmen, Sr. Signallers and Sr. Train Clerks, all in Level-4, and Leverman Gr.1, Pointsman Gr.1, Shuntman Gr.1, Cabin man Gr.II and Train Clerks, all in Level-2.

(b) Shunting Master/Jamadar & TNCS, in Level-6 are also eligible for promotion to the post of Station Master in Level-6 against the 25% General Selection Quota. This will be treated as lateral transfer and not entitled for fixation of pay in same level of Station Masters.

(c) Staff in Level-1(erstwhile 6th CPC GP Rs.1800) of the Operating Department who are matriculates, and have 5 years of regular service in Operating Department.

ii. **Education qualification:** The applicant must possess the qualification of matriculation.

iii. **Age:** Upper age limit of 45 years (50 years in case of SC/ST). (Authority RBE No.79/2023, Rly. Bds letter dated 13.06.2023)

iv. **Medical Fitness:** Aye-Two Medical classification is mandatory for the post of Station Master.

(Annexure-IV of para 510(2) of IRMM & Railway Boards letter No. 99/H/7/1 NR dt. 30.05.2003)

v. After passing the written examination, it will be mandatory for the selected employees to pass

Aptitude test and prescribed initial training course at ZRTI/BSL or at similar training centre. Before promotion, they will have to undergo practical training related to the duties of Station Master.

3. **Pre-Selection coaching:** The pre-promotional training for eligible "SC/ST" Volunteers is to be conducted covering the syllabus of the examination for selection to the safety category posts and will be imparted for a period of 03 to 04 weeks. In case if any employee expresses his/her unwillingness for pre-promotion training, a written declaration to the effect may be forwarded to this office. (Authority Railway Boards letter No. 88- E(SCT)1/42/2 dated 11.04.1991).

4. **Syllabus:** A syllabus for the above selection is attached as Annexure -B.

5. **Procedure for written Examination (CBT):**

a. The exam will be held in the manner of Computer/Tablet Based Test (CBT).
(Authority: Railway Board's L.No.2025/E(RRB)/25/14 dated 21.08.2025).

b. The existing system of examination conducted for filing for promotional posts has been reviewed by the Board bring objectivity to the selection process it has been decided are as under :

i. Question paper will be 100% objective type.
ii. All the questions will be of multiple choices only. (Authority: As per Railway Board's L.No.E(NG)I/2018/PM-1/4 RBE No. 196/2018 dated 14.12.2018, RBE No.97/2019 & RBE No.194/2019).

iii. There will be 110 questions including 10 optional questions on official language policy and candidates will have to answer 100 questions only. If any candidate answers more than 100 questions, the first 100 attempted questions will be counted. (Authority: Railway Board's L.No.Hindi-2010/OL-1/10/4 dated 14.12.2016)

iv. The duration of examination under objective type multiple choices will be 120 minutes.

v. There will be no viva-voce in the Selection held for promotion from Group 'D' to Group 'C'.
(Authority: RBE 165/2003 dated 22.09.2003).

vi. The post of Station Master being safety category, there will be no relaxation in qualifying marks for candidates belongs to SC/ST community.

vii. There will be No Supplementary Examination.

6. **Notifying to the employees:** The controlling officer/Supervisors should give wide publicity to the notification to all the eligible staff of Operating Department of Bhusawal Division and notification should be displayed at notice Board/Conspicuous place. It is the responsibility of the controlling officer/supervisor to circulate the notification among the staff concerned.

7. **How to apply:** i. The employee those who desire to be considered for the post of Station Master should submit their applications in the prescribed Performa enclosed herewith as **Annexure-A** through proper channel, duly forwarded by their Sub-ordinate In-charge so as to reach in this office latest by **19/12/2025** in sealed cover envelope addressed to DRM (P) BSL, DRM Office, Personnel Branch, Bhusawal.

ii. The applications should be of good quality of A-4 size paper using one side only.

iii. The employees should fill up the application form in their own writing with blue or black ball point pen only.

iv. All the relevant columns in the application should be filled completely and strike out the inapplicable columns and forwarded duly signed by the controlling supervisor/officer with date wherever required of otherwise same will not be considered.

v. Application received without forwarding by the concerned supervisor's official letter with date, Incomplete and application received after due date will not be entertained. The same will be rejected and no correspondence will be made in the matter.

vi. Applicant should enclose attested copies of certificates as proof of their educational qualification, Date of Birth and community (in respect of SC/ST employee) along with his/her application, otherwise their application is liable for rejection.

vii. Employee should paste the recent photograph on the application which shall be attested by the concerned supervisor along with stamp.

viii. Eligible staff on deputation to other offices, but holding lien of Bhusawal Division may also submit application through their respective supervisory official. The application should reach to this office on or before **19.12.2025**. Concerned Branch officer and Supervisory officials should inform such staff.

ix. If, application not received within stipulated time in this office as mentioned above even after submitted by employee to the concerned supervisor within the time, then the concerned supervisory official will be held responsible for the delay.

x. Eligible employees are hereby advised to treat this notification itself as intimation to the written examination/CBT and they should be in readiness for the same within a short notice.

xi. Candidates applying for the selection should ensure entry of educational qualifications, Community, Railway week award and etc. in their Service Record before scrutiny of applications, so as to publish the Eligible/Ineligible list for the selection. No representation will be entertained after publishing the eligible/ ineligible list.
